REVENUE OF 111,9 M€ FOR THE 1ST HALF-YEAR 2020 UP +4%

Contacts Consulting has been consolidated since February 1st 2019, Océane Consulting Nord since July 1st 2019, Neonn since August 1st 2019 and Ebiznext since December 1st 2019.

Umanis (Euronext Growth - FR0013263878 - ALUMS) generated a consolidated revenue of € 50.7 million in the 2nd Quarter of 2020, a slight decrease of -2% compared to last year. As was to be expected, the Covid-19 health crisis had a greater impact in the 2nd quarter.

However, past the initial shock on business during the implementation of lockdown measures in mid-March, business levels remained broadly linear over the whole quarter (excluding working days effect). The service center organization model and the smooth running of the company's business continuity plan enabled Umanis to cope with the impacts of the crisis.

Over the first Half-Year, revenue thus stood at € 111.9 million, up slightly by + 4%.

During this period, Umanis benefited from the consolidation within the Group of the three companies acquired in the second half of 2019: Océane Consulting, Neonn and Ebiznext. Contacts Consulting and Océane Consulting were merged into Umanis SA retroactively to January 1, 2020.

PROSPECTS

The situation today remains uncertain and extremely changing. It remains difficult to assess the consequences on business and more generally on the economic environment in the coming months.

In this context, the group does not wish to set financial goals for the 2020 financial year.
